Upon acceptance of this agreement by MKC BEAUTY ACADEMY (hereafter "the Academy"), this constitutes a binding enrollment agreement between the Academy and the undersigned student. I am enrolling in the Academy Course(s) to increase my knowledge and skills as a make-up artist and not for any other purpose. I further certify that I am not an employee or agent of any competing business.

I agree that the equipment and information that I receive as a student in the course ("Academy Materials") are confidential and proprietary to the Academy, and I will not copy or cause to be copied or reproduced in any manner, electronic or otherwise, any of the Academy Materials. I understand that I will receive the Academy Materials only when I have paid my tuition in full, and I further understand that upon receipt of the Academy Materials, I am responsible for the full value of the Academy Materials as stated, any alteration of Academy Materials will be at the student's sole risk and expense. In order to exchange a broken or damaged unused Academy Materials, I must notify a representative of the Academy within 24 hours of receipt of Academy Materials.

I understand that the Academy has the right to drop any student from the course at any time for any, refunding only the remaining tuition due as explained in the refund cancellation policy as set forth by the Bureau of Private, Postsecondary and Vocational Education. I understand that the Academy will assess a \$25.00 service fee for any check written by me that is not honored by my bank for any reason. I agree that in any legal action arising out of this agreement, the prevailing party shall be entitled to reasonable legal fees and costs incurred in the proceeding.

Student Tuition Recovery Fund

You must pay the state-imposed fee for the Student Tuition Recovery Fund (STRF) if all of the following applies to you:

- You are a student, who is a California resident and prepays all or part of your tuition either by cash, guaranteed student loans, or personal loans, and
- Your total charges are not paid by any third-party payer such as an employer, government program or other payer unless you have a separate agreement to repay the third party.

You are not eligible for protection from the STRF and you are not required to pay the STRF fee, if either of the following applies:

- You are not a California resident.
- Your total charges are paid by a third party, such as an employer, government program or other payer, and you have no separate agreement to repay the third party.

BUYER'S RIGHT TO CANCEL

A student of MKC Beauty Academy has the right to a full refund of all charges, less the \$75.00 registration fee, if the student cancels his/her enrollment agreement prior to or on the first day of instruction. The amount retained for the registration fee may not exceed seventy-five dollars (\$75.00).

If a student has completed 60% or less of the course instruction, the student may withdraw from any course after the first day of instruction and receive a prorated refund for the unused tuition and any other refundable charges, less the \$75 non-refundable registration fee. For example, if a student completes only 40 hours of a 343-hour program and paid \$11,700.00 tuition, the student would receive a refund of \$10,260.60. Tuition of \$11,700.00 / 343 total hours = \$34.11 per hour x 40 completed hours = \$1364.40 value of hours attended + \$75 non-refundable Registration Fee = \$1,439.40. Tuition of \$11,700 - \$1,439.40 = Refund Due of \$10,260.60.

The student will also be refunded any money collected from third parties on the student's behalf. If MKC Beauty Academy cancels or discontinues any course or educational program, the school will refund all appropriate charges. If the student obtains a loan to pay for the course of instruction, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund. Refunds will be paid within 30 days after MKC Beauty Academy receives written notice of cancellation and the student's withdrawal has been determined.

You may cancel your contract for school with the Notice of Cancellation form that will be given to you at the first class you attend. The cancellation should be sent or delivered to the School Director at 3603 Seneca Avenue, Los Angeles, CA 90039.
