Career Development: Marketing, Networking, and Success Coaching makeup an integral part of the MKC Beauty Academy curriculum. These supplemental lessons are included at no extra charge in every MKC Beauty Academy program. A few of the subjects included in these supplemental courses are portfolios preparation, resume writing, self-marketing, career plans, networking, and professionalism. During these workshops, professionals in each field will share their ideas and experiences and answer questions from the students while leading students through exercises and open discussions.

To assist graduates with marketing and self-promotion MKC Beauty Academy provides each graduate with an online website portfolio. Through their partnership with The Portfolio Network, MKC Beauty Academy provides free online website portfolios for one year, along with one free website portfolio training session.

Through affiliations with companies like Pacific Television Center, Legacy MP, Missy Farren & Associates, Ltd, L'TITIA, Lola Cosmetics, Pixi Cosmetics, Bloom Cosmetics and others, the MKC job board is a powerful tool to assist graduates in locating work after graduation - although placement is not guaranteed. The MKC job board and all post-graduate career services, including portfolio preparation, resume writing, and job placement assistance are available to all Masters Program and Professional Program graduates.

MKC Beauty Academy is very proud of our 2005 Masters Program graduation/employment rate. Of the 31 students who began this course, 29 graduated (94%) and 21 graduates of this course are confirmed to be employed (72%). (Only 21 students responded to our enquiry)

(The Professional Makeup Artist Program is new and we are not able to tell you how many students graduate, how many students find jobs, or how much money you can earn after finishing this course, we are very proud of the accomplishments we have made and look forward to many more years offering.)

MKC Beauty Academy makes no claims to what salary a graduate may expect upon graduation.

Housing: MKC Beauty Academy maintains a list of available housing and will assist the student in securing a lease, renting furniture, and obtaining transportation.

International Students: To qualify for a visitor or student visa, an applicant must meet the requirements of sections 101(a)(15)(B) or (F) of the INA respectively. Failure to do so will result in a refusal of a visa under INA 214(b).

Financial Assistance: A new addition to the MKC Beauty Academy family is SLM Financial a Sallie Mae company. SLM provides student loans to qualified applicants or applicants and qualified co borrowers. Loans can cover tuition and up to 60% or \$6000 to cover equipment and living expenses.
